
Who is W. Nanner Flint?

Debate the existence of God, but no one debates the existence of money. There may be many gods but all worship



### How to Land a Legal Job Overseas



### Law and Rockets An American Lawyer in Iraq






### **Snowjob** My Life in the Medellin Cartel


